OBITUARY.

Lord Ossington.

The Right Hon. John Evelyn Denison, Lord Ossington, died at his residence, Ossington, Notts, England, during the night of the 6th inst., from the effects of a severe, sudden attack of bronchial dis ease and general debility. He was in the seventythird year of his age. John Evelyn Denison was the eldest son of the late John Denison, Esq., M. P., of Ossington, by his wife Charlotte, daughter of Samuel Eastwicke, Esq. He was born in the year 1800 and succeeded to the estate in the year 1820. He was educated at Eton and Christ Church College, Oxford, graduating Eachelor of Arts in 1823 and Master of Arts in 1828. In the year 1827 he married Lady Charlette Cavendish, third daughter of William Henry Cavendish, fourth Duke of Portland. He was returned to the House of Commons, as member for Newcastie-under-Lyne, in the year 1823, and represented the constituency till 1826. He was commissioned a Lord of the Admiratty, and served from 1827 to the following year. He represented the electors of Hastings in Parliament from 1826 to 1830; those of Notts from 1831 to 1832; of South Notts from 1833 to 1837; of Malton from 1841 to 1857; of North Notts in 1867. He was chesen Speaker of-the House of Commons in 1867, and sworn in a Privy Councillor of Great Britain. He performed the duties of his office as Speaker with great dignity and impartiality, and retired from his eminent position of his own free will, to the great regret of the members of the House. Her Majesty, Queen Victoria, elevated him to the peerage, an honor which he was permitted to enjoy during a brief period only. was educated at Eton and Christ Church College,

James Haughton. By mail from Ireland we are informed of the death, at his residence, in Dublin, of James Haugh ton, J. P., the well known advecate of temperance and a distinguished merchant. He was in the seventy-eighth year of his age. Few names were better known in Great Britain and generally among Irishmen at home and in foreign lands fo the past thirty-five years than that of James Haughton. He was of Quaker origin, and was born in Carlow, but resided in Dubin for the greater part of his life. About twenty-three years e retired from commercial pursuits, and devoted himself to various philanthropic labors which had also previously occupied much of his time. He was a stanch supporter of O'Connell in politics, only differing from him for a short period when he thought that freedom of discussion was To his urgent instigation were mainly due some of O'Connell's neblest denunciations of negro slavery. Mr. Haughton was a thorough free trader and advocated direct taxation. On the two occasions when John Eright visited Ireland and spoke on the land question and free trade, he was the guest of the deceased gentleman. He was strenuously opposed to war and capital punishment. He belonged to the liberal or progressive school of pontics, believing thoroughly in man's capability of improvement by means of sound education and the practice of freedom. He was a most uncompromising adversary of slavery (indeed of all sorts of tyranny), and some of his most severe letters were written against that long curse of the United States. His heart, nowever, was more deeply enlisted in the cause of temperance or tectotalism than in any other question. He devoted much of his time and momey in promoting the movement. Mr. Haughton worked for a considerable time with Futher Mathew (and for him when pecuniary difficulties overtook him), and for many years with the late Very Rev. Dr. Spratt. He lectured week after week to reclaim some of the peopest and most miserable of the people of Dublin, carning the blessings of the lewly. The stabilishment of the Dublin Mechanics' Institution in its present position was mainly due to the mainly due some of O'Connell's t denunciations of negro slavery. Haughton was a thorough free establishment of the Jubin Mechanics Institution in its present position was mainly due to the exertions of Mr. Houghton, and he continued to the last to take a deep interest in its weliare, even after he ceased to take an active part in the proceedings. With the late Robert Ball he succeeded in persuading the then Council in the proceedings. With the late Robert Ball he succeeded in persuading the then Council of the Zoelogical Society to epen their gardens at ene penny on Sundays. To him the pablic are indebted for repeated efforts, as member of the Royal Dublin Society, to induce that body to open the Botanic Gardens en Sunday atternoon—a measure long resisted, but now approved of by all. In conjunction with the late Mr. Senior (Poor Law Commissioner) he called the late Lord Carlisie's attention to the neglected state of the Park, and the People's Garden and other minor improvements were ultimately carried out under the Viceroyalty of that mobleman. He wrote and spoke also on various public questions, and contributed a number of valuable papers to the Royal Dublin Society and to the Statistical and Social Inquiry Society, of both of which he was an active member. Among other reforms brought about by his persistent exertions was the reduction of the postal charges to America. It is only within little more than a year that feeble health compelled him to withdraw from all work, except friendly correspondence and reading. He was a tectotaller for thirty-five years, and a vegetarian for some twenty-six years, being at the time of his death President of the Vegetarian Society of the United Kingdom.

Henry Van Wart. The remains of Henry Van Wart, the veteran merchant of Birmingham, England whose death was briefly announced a short time since—were interred near the city in which he lived and died. He was carried off from life at the age of ninety years. Mr. Van Wart died at his house, in the Hagley Road, Edgbaston. He had kept his room for some time, occasionally mending, then growing worse again, and then rallying once more; but again, and then rallying once more; but at his great age each successive attack weak-ened the system, and at last he succumbed. It is a long way to go back to 1783, the date of Mr. Van Wart's birth: the "year of the peace," when George the Third found out and acknowledged that he could not beat his rebellious subjects in America. In one way Mr. Van Wart was connected with the War of Independence; his family—Dutch or German by extraction—were citizens of the young Republic, and his grandfather (we believe) was one of the three militiamen who arrested Major André, fresh from his interview with the traitor Arnoid. Mr. Van Wart was born at Tarrytown, a village on the Hudson River, about thirty miles from New York, since made famous by Washington Irving's legend of "Sleepy Hollow." His lather was a small farmer; but the son had larger ideas chan Tarrytown could satisfy, and so he went into trade as a clerk in the house of irving & smith, merchants, New York. Young Van Wart made quick progress. In 1806, in his twenty-third year, he married Miss Sarah Irving, the youngest sister of his employer, and the sister, also, of Washington Irving. Immediately atterward he was despatched to Liverpool to represent the firm in Engiand. In 1808, when there was apprehension of an outbreak of war between Great Britain and the United States. Mr. Van Wart went back to New York; but he did not stay there long, for in the same year he returned to England, and settled permanently in Birmingham as an American merchant. Since that period he continued, until his death, to carry on his business in Birmingham—a sare example of a man remaining actively in trade for an unbroken term of sixty-five years. He was not a keen politician; for example, he took no part in the famous political union, though when Birmingham had received Parliamentary representation he supported Messrs. Attwood and Scholefiel as the first members. In later years the whig opinions he mostly held reasserted for Birmingham, Mr. Van Wart was a prominent supporter of Mr. Aclan at his great age each successive attack weakened the system, and at last he succumbed.

sut two visits to the United States after he finally settled in England. One of these had nearly proved fatai to him. The steamer in which he was a passenger was cast away in Long Island Sound. Mr. Van Wart remained on board till the last man had quitted the vessel. He clung to part of the wreck until he began to lose vitality from cold, and then letting go he plunged into the water and swam or floated ashore. He had not, however, sufficient power to land; but, happily, two fishermen saw him and drew him up, carried him on their shoulders to a farm house half a mile off, and managed to restore him to life. Another steamboat accident is worth recording. Mr. Van Wart was a passenger in the Fulton—the first steam vessel named after Robert Fulton, her inventor—on her experimental voyage on the Hudson River, from New York to Albuny. Owing to a derangement of the machinery, by which one of paddles was prevented from working, the captain of the vessel proposed to give up the attempt to proceed; and it was due to the encouraging conscion of the new principle.

Virginie Chesquieres A woman named Virginie Chesquières has died in the Petits-Ménages Asylum, at Issy, France, within fifty-five days of attaining her hundredth year. A remarkable act of heroism is related of this female the Peninsula war the colonel of the Twenty-seventh regiment had been killed, and left on the ground, when a sergeant, a slight young man, and two soldiers devoted themselves to recovering the body of their officer. They started together, but the two men were struck down on the way, and the sergeant only reached the spot. He attempted to litt the corpse on to his shoulders, but was too weak to do so. Perceiving two of the enemy at a distance, he made signs as if he were weunded, and the others hastened forward expecting to make a prisoner, when the sergeant fired and brought down one of them, then seized his horse—the other had fled—got the body on it, mounted himself, and galloped back to the French lines. There it was seen that the young man was himself wounded, as blood was flowing freely from his breast; he was undressed in spite of his resistance, when he was found to be a woman! It was Virgtnie Chesquieres, of Delmont, in the department of the Nord, who, six years before, seeing her young brother drawn in the conscription, had dressed herself in men's clotues, and, taking his place, had been incorperated in the Twenty-seventh regiment, and had risen to the grade of sergeant. Henry T. Lowry-Corry. The Right Hon. Henry Taomas Lowry-Corry, member for the county of Tyrone, Ireland, in the British Parliament, has just died at the age of seventy years. Mr. Corry was the second son of the second Earl of Belmore, by his wife Juliana, the second Earl of Belmore, by his wife Juliana, daughter of the Earl of Carrick. He was born in the year 1803, and graduated at Christ Church, Oxford. In the year 1830 he married Harriet Ann, daughter of the Earl of Shaftesbury. He has filled the offices of Comptroller of the Household to Queen Victoria, a junior Lord of the Admiralty, Secretary to the Admiralty, Vice President of the Council on Education, and of First Lord of the Admiralty. He was sworn in a Privy Councillor of England in the year 1835. Mr. Corry, who was a strict conservative in politics, had represented the county of Tyrone in Farliament continuously from the year 1826.

TERRIBLE DISASTER AT SMYRNA.

The Levant Herald of February 12, contains the following additional particulars respecting the fall of a case at Smyrna:-

On Sunday night at ten o'clock the Café Kivoto, buit upon piles on the sea, broke down suddenly during a performance given by a company of acrobats. The proprietor of the caje says that he only sold 108 tickets, but the people saved declare that there were 200 persons present. Most of them were of the poorer class, and there were not many Turks there, or young men of respectable families. At ten o'clock a loud cracking was heard, and within five minutes the entire caje had disappeared under water. A few of the persons near the entrance contrived to effect their escape, and some persons saved themselves by jumping through the whindows into the sea. The boatmen rowed up in numbers, but their efforts to save life were in vain. Sureya Pacha, the Governor General; Ibrahim Agha, Chief of Police, and Tahir Bey, Commander of the Gendarmerie, who were at once on the spot, exerted themselves strenuously but fruitlessly, with the same object. The profound silence which succeeded the piercing cries of despair told too plannip the terrible character of the disaster. The Catholic and Greek Archbishops were on the spot early the following morning. Yesterday forenson the workmen of the Quay Company were actively engaged in removing the reor of the submerged caje. The scarch after the dead bodies was a sad spectacle; the acrobats were withdrawn from the water in their showy costumes of the previous night; the limbs of all the bodies were contracted with pain. Two hearses were engaged the whole of the day in conveying the remains discovered to the hospitals. Of the fifty bodies deposited at the Greek hospital twenty-eight were claimed up to four o'clock yesterday afternoon, and eleven were claimed at the Catholic hospital. Divers were busy at work all day, and every minute a fresh body was abrought up. To-day they recommenced their melancholy task at daybreak, and twenty more claimed at the Catholic hospital. The total number of bodies recovered up to the present is eighty, and it is supposed that there are still fifty more in the water. An English captain, two Turkish morchants, a young man of good connections, an Italian captain, a telegraph clerk, and some commercial clerks are among the victims. The feeling of grief and consternation is general, and the ball advertised to take place in the Casino has been countermanded. The company of acrobats consisted of seven persons, of whom three were women, and one of these latter only survives. Naval Cadets in Washington. Officials at the Navy Department are mortified at the charge made of neglecting to provide for the comfort of the naval cadets on the occasion of their visit on inauguration day, as it would seem to imply disrespect toward an important branch of the public service. The military cadets were quartered at and provided for at one of the principal hotels, but the naval cadets, being within two hours' travel by rail, were provided with a special train, accompanied by their commissary, and had everything furnished that comfort and convenience could suggest. 'Owing to the great numbers of cars concentrated at Washington depot, the cadets' train was switched off two miles from the terminus, and the youngsters compelled to march in as well as march out again. The crowded condition of the city and not the naval officials is alone re sponsible for discomforts experienced on the day when the Commander-in-Chief of the Army and Navy was sworn into office.
