THE MURDER AND THE CIRCUMSTANCES.

The victim of McElhany was his own wife. It was under these circumstances that McElhany went to see his wife on Winsor street, at the residence of the mother-in-law, on the afternoon of the 17th of August last. He gained access to a room where she and her only child were seated, and almost instantly drew a revolver and shot his wife dead. The other occupants of the house, hearing the report, rushed in, and the mother-in-law to anybody he immediately.
